What is Pharmaceuticals 2027?

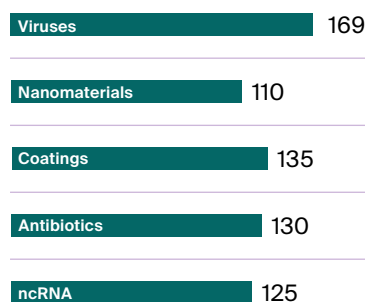

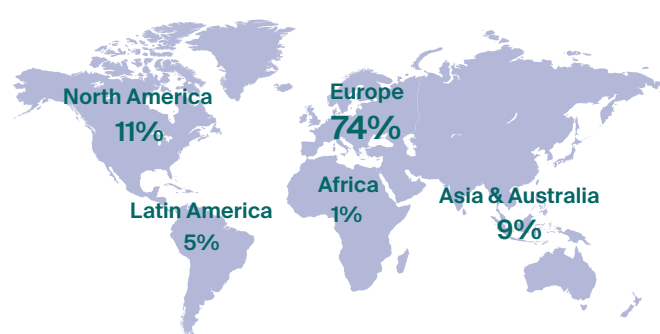
The conference will focus on a diverse range of topics, including:

- Pharmacokinetics, Pharmacodynamics, and Clinical Pharmaceuticals

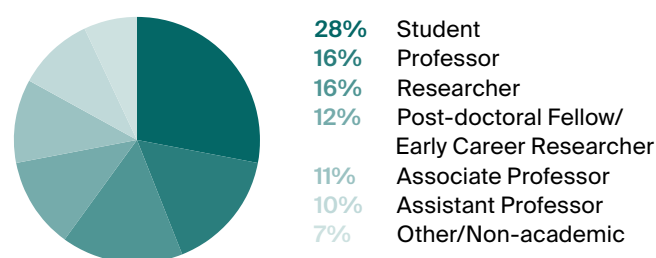
Number of attendees in MDPI conferences in 2026
